<u>Call to Order</u>: A meeting of the New Jersey Intergovernmental Insurance Fund was called to order on Thursday, May 26,2022, at 10:03 a.m. via Zoom (video and telephonic) conference. - 4. <u>Finance Report</u>: In the absence of CFO Calise at the meeting, Chairman Tucci tabled the May Finance Report for the NJIIF's June 23, 2022 Meeting.
- 5. <u>Chairman's Report</u>: Chairman Tucci asked GC/C o-Admin Nemeth if the NJIIF has adequate firms on its defense counsel panel lists. GC/Co-Administrator Nemeth reported that his office recently posted an RFP for the ML Fund Panel Counsel position and will consider similar action for the WC Fund. Nemeth also reported that due to a change in staffing, until further notice, the City of Bayonne will not be defending its own lower risk AL and GL matters and that new counsel will need to be assigned to their existing cases.

GC/Co-Admin Nemeth reported that although the 2022 Cyber Liability policy, as issued, is correct, there was a clerical error identified in the NJIIF's 2022 Risk Management Plan (the cyber coverage reflected the 2021policy terms). Chairman Tucci requested that an amended RMP be prepared and introduced for adoption at the June 23, 2022 Executive Board Meeting.

- 7. <u>Risk Manager's Report</u> (Polaris Galaxy). J. Gallo advised that he received new informational flyers from the NJIIIF's EAP Plan provider, the Sand Creek Group, that will be disseminated to the members. Gallo also advised that Acrisure anticipates having Property renewal quotes ready to review soon. Also they will be presenting an option for a potential increase in the limits for blanket crime coverage.
- 8. <u>Loss Control Consultant Report</u> –(PMA) Tim Weir introduced John Matthews, who recently joined the NJIIF Risk Control service team, who was in attendance at the meeting. Additionally, Weir reported that the latest edition of PMA's "Safety Seen" newsletter was recently sent for the month of May. Weir also announced PMA upcoming training regarding lightning hazard awareness.
- 9. <u>TPA Report</u> (PMA) Jennifer Signs provided an update on aggregate WC claims received through 5/1/22, including the number of reported COVID cases. She advised that claims generally continue to be timely reported. Signs also advised that the NJIIF has a total of 365 reported COVID cases (41 in 2022, 137 in 2021 and 187 in 2020), with 84 related claim petitions filed to date.
